GENERAL MEETING
Minutes - October 19, 2009

President Barbara Cleaveland called the meeting to order at 10:00 a.m. and led us in a Moment of Silence asking us to remember Olivia Bryan and Ray Tompkins.

BUSINESS

Minutes: The minutes of the General Meeting, September 21, 2009, were accepted as posted.

Corresponding Secretary: Adele Hudson reported that during the past month, she has sent out three cards to Cadbury residents and two are being prepared to be sent.

Treasurer: As Diantha Pack was not able to be present, President Barbara gave report. Balance as of 9/14/09 was \$4,125.07. Income for September was \$6,510.00. expenses were \$826.28, leaving a balance of \$9,808.79.

COMMITTEE REPORTS

Activities: Don Burgess mentioned that this is CALRA budget time, and requested all activity committees to give thought to their needs and submit a request to him in writing. He is referring to groups such as The Watercolor Society, the ReCyclers, the Bridge Group, the Walking Club, Scrabble Club, Canasta Club, Needlework Group, Camera Club. The Wii Bowling team has already submitted a request.

Upcoming events include the Clear Space Production of *100 Years of Broadway* (51 Cadbury residents have signed up for this one) and the musical version of *Dickens' A Christmas Carol* December 10-13. The Saturday evenings with the Dean Martin Show will be alternating with Saturday evenings with the Carol Burnett Show.

Gift Shop: Jeanne Sparks thanked those who responded to her request for substitutes at the Shop. They were open during the recent Festival and were pleased to make sales to visitors. They are working on making residents of the Tides and their families aware of the shop and items available for sale. The financial report for September: Income was \$363.25, expenses \$316.83. Net profit \$46.83. Total profit since January 1, 2009, is \$1,709.38.

Membership: Dick Cleaveland reported that there is no change in the number of units occupied here at Cadbury, 54 people attended the last General Meeting and the Menu list is still the most popular on the web site.

Newsletter: Pat O'Hanlon reported that she has received several items for the Newsletter and is looking for more - - November is right around the corner.

Program: Sharon Hoover, puzzled as to why our speaker for this morning's program did not arrive, reported that the speaker for the Tuesday evening program will be Judith Roales, president of the Delaware River and Bay Lighthouse Foundation.

Woodworking: Dean Hoover mentioned that the wood working shop is busy and urged people to drop by to see them or even join them.

Dial-A-Ride: President Barbara pointed out that this is a service to give rides to people going to Doctors' or dentists' appointments.

Nominating Committee: Bob Hein reported that the official announcement will be at the November meeting. Nominations from the floor may be made, provided that permission has been given by the nominee.

OLD BUSINESS


President Barbara reminded everyone that donations are being accepted for the Food Drive which will continue into November.
