Opening Remarks

Results of my two meetings with Annette regarding the recent resident's concerns: Gazebo and Memory Walkway

- Hopefully, the Gazebo and Memory Walkway will remain near their current location.
- Should the Gazebo or Memory Walkway need to be relocated, Annette's suggestion is to create a garden on the east side of the flagpole in front of the building, a place of dedication for the memorial bricks, and a new gazebo. Regardless of where the Memory Walkway lands (along with the memorial bricks) it will be recreated and incorporated with thought and design per Mr. Midgett's instruction.
- Shuffleboard courts will remain practically where they are now.
- Two new shuffleboard courts will be installed at the conclusion of the expansion.
- If necessary, temporary courts will be constructed so the shuffleboard season can continue during the expansion.
- A bocce ball court will be added in the same area.
- Between the shuffleboard courts and the bocce ball court a covered pavilion with seating will be constructed.

Concern was expressed about how these courts can be safely installed on a slope. The pickleball courts are still being researched.

- The Development Team is aware of the potential injuries associated with pickleball.
- Case Law is being looked at regarding lawsuits concerning noise pollution.
- Low-noise paddles, low-noise pickleball court construction, and low-noise pickle balls would be used.
 - A comment indicated that noise reducing equipment would not make quiet players.
- The pickleball courts will be fenced with a locking mechanism used. There will be no lights. A six-foot berm with trees will be constructed to the rear of the courts.
- Although the Springpoint Development Team feels residents have asked good questions, they are still interested in including Pickleball for Marketing reasons.

I sent Annette copies of comments I received recently regarding the expansion on April 15. The comments primarily focused on the pickleball and bocce ball courts. I tried to eliminate comments on issues already asked and answered. Upon request, a copy of this letter is available to the residents.

Because of recent experience, Annette requested that if an IL resident is approached unsolicited by a family member with complaints, the resident should refer the family member to James or herself and also let one of them know of the incident.

A lengthy discussion of this issue concluded that residents are not obligated to report complaints from visitors. However, Don stated he feels it is important to relay complaints to the Director of Resident Services or the Executive Director since concerns verbalized publicly by non-residents might negatively impact The Moorings' reputation.

To request a work order either call or email. Emails can be easily sent through the Community App. Bud prefers emails so that residents have a written record.

Items of interest from the Springpoint LPC Boards of Trustees, 3/21/2024

• <u>Dining Service</u>: Management is vitally interested in having high quality dining service on a consistent basis. They believe Compass will be better able to achieve this goal.

They are looking to adopt plans similar to our Declining Balance plan. I have discussed our plan with Monroe Village folks and they want to implement our plan.

- Workforce: Springpoint (SP) is looking to bring in foreign labor. The most interesting point is bringing in Canadian nurses.
- <u>Information Technology:</u> SP will be implementing multifactor authentication. This is aimed at upgrading computer system security.

They are considering a new system for dining for all LPC's.

• <u>2023 Financial</u>: Across all 8 LPC's revenue was on budget. Operating expenses, in aggregate, were slightly over budget, but the Moorings and 3 others were under budget. Operating margin came in at 20%, slightly below budget of 23%.

Library Committee Report

Our Library has been receiving many DVDs, some from the Program Committee, and we have run out of shelf space for these contributions. The current bookcase where these DVDs are kept has five fixed shelves. These shelves are not able to be adjusted or moved as the edges have been grooved into the side boards of the bookshelves. Five members of the committee met to come up with ideas to deal with this problem and thought the only way was to have a new shelf built to hold more DVDs. We thought that one of the maintenance men might be able to build us one - a moonlighting job. I spoke with Bud, our Maintenance chief. He preferred to do the job in-house. We went up to the library so he could see the problem. According to my calculations the existing shelf system is able to hold about 120 DVDs. A shelf system of a different design could hold 224 DVDs. Bud doesn't have any idea of the cost of the lumber for this job, so it is still in the idea stage.

Wellness Committee Reports

Talk presented by Ann DeLazaro, Director of Provider Services for Delaware Hospice.

- 1. Stressed the importance of:
 - Communication between the patient and the physician, remembering it is your right to question.
 - The importance of having an Advance Directive in place.
 - Conversations among family members so the patient's desires are known.
- 2. Hospice and Palliative Care are like comparing apples and oranges. Hospice offers comfort. Palliative is curative. The goal of Hospice is to keep the patient at home and comfortable until the end of life. There is no time limit to hospice care. Example, Jimmy Carter.
- 3. Palliative Care is curative, for those who benefit from Support Services, more than direct care. Examples are Parkinson's Disease, Early Dementia. This is a team effort. Hospital and Social Worker assists family and friends. A nurse acts as a buffer between care giver and patient. An example would be for a patient with Parkinson's Disease. They begin with Palliative Care. Also true of early Dementia.
- 4. Anyone may make a referral to Hospice.
- 5. There is an in-patient facility in Milford and one in Wilmington. May be utilized when more care than is possible to be offered at home. Patient will be returned to home when possible, and comfort care will be continued. This includes medication to alleviate pain, and spiritual comfort as desired.
- 6. An admission nurse is the first to assess the patient, who is scored according to need. The higher the score, the more appropriate for Hospice. This may include patients with lung issues, heart disease, cancer, multiple sclerosis, etc.
- 7. Some patients graduate from Hospice, this is termed "revoke status". They may return when needed. There is no time limit to Hospice.
- 8. Delaware Hospice is the only Hospice Program in Delaware that has A program specifically for children, "Katybug". where the Nurse Practitioners, nurses and Social Workers are specifically trained to work with children.
- 9. Delaware Hospice is a non-profit facility. There is no charge for Hospice. Gail Bourassa

Building and Property Committee Report

In my report of the February 20th B&PC meeting last month, I had an incomplete report on one subject, the work planned on the cottage downspouts. After reviewing it with Bud Hirschmann, I can tell you the focus of the work will be on removing the problem of rainwater flowing onto concrete surfaces where it can freeze and provide dangerous conditions. An attempt will be made to reroute the water in the overhead gutters away from the paved areas to other corners of the cottages where it can runoff in grassy areas. Where that is not able to be done, the downspout's runoff will be run though the concrete and out underground to the grassy areas. So, the problem will be alleviated one way or the other.
